## OFFICIALS WAIVER AND RELEASE OF LIABILITY

### READ BEFORE SIGNING

In consideration of being allowed to officiate at indoor facilities supported by NOISOA, the undersigned acknowledges, appreciates, and agrees that:

1. That when I am engaged as a soccer official at any of the indoor facilities, I am an independent contractor and not an employee, and agree to accept the game fees published by the separate facility for my services; and
2. I recognize the risk of injury from these activities involved does exist. I KNOWINGLY AND **FREELY** ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE **NEGLIGENCE** OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for officials. If, however, I observe any unusual significant hazard while performing my duties, I will remove myself from participation and bring such to the attention of the nearest employee immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS** the indoor facility or NOISOA their officers, agents, and /or employees, other officials, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property. WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT,
